Please return the completed application form to the institution in which you are admitted to an eligible programme to confirm your agreement to apply for the subsidy under NMTSS via the institution concerned for offsetting tuition fee payable. Please ensure that the information provided on this application form is true, complete and accurate and inform the institution concerned as soon as possible if there are any changes subsequently (e.g. admission to subsidised undergraduate programmes vide Part 2 Item 2 below). The institution and the Education Bureau (EDB) will assess your eligibility based on the updated information.
- 2. Eligible students only need to pay the tuition fees net of subsidy. Subsidies will be disbursed to the institutions concerned directly. Once a student paid the tuition fee net of the subsidy (together with this application form as appropriate) to the institution concerned, if he/she subsequently chooses to withdraw from the programme concerned and change to another eligible programme under NMTSS, he/she should not submit another application for the same semester which will not be accepted by the EDB¹. However, he/she may still make an application afresh in the following semester for pursuing the eligible programme he/she switches to but he/she is allowed to change programme once only ² under NMTSS.
- 3. The subsidy will be tenable for the normal duration of the relevant programme. Students are <u>not required to re-submit</u> the application every AY but must inform the institutions concerned as soon as possible in case of subsequent changes to the information provided on the application form. If a student chooses to discontinue his/her current study to pursue another eligible programme under NMTSS ², he/she must submit an application afresh.
- 4. Please pay attention to the application deadline set by the institution concerned, and return the completed form to the institution before the deadline. Except for special circumstances ³, applications submitted to the institutions concerned after 30 September 2023 (for 1st semester) or 31 March 2024 (for 2nd semester) will not be processed.
